I. Consortium composition

1. What are the requirements regarding the consortium composition?

Each consortium must include at least three (3) independent legal and performing actions entities from at least three different EU Member States or Euratom Programme associated countries, including at least one external entity.

It is not mandatory to include a beneficiary or an affiliated entity to perform the project, but this would be easier from an administrative point of view.

Consequently, a consortium can be formed by third parties only.

An external entity is a legal entity which is not part of the consortium at the time of the launch of the first open call (please refer to annex 1 of the call text to check which entity is already part of PIANFORTE).

The notion of independence in article 8 of "REGULATION (EU) No 1290/2013 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 11 December 2013 laying down the rules for participation and dissemination in "Horizon 2020 - the Framework Programme for Research and Innovation (2014-2020)" and repealing Regulation (EC) No 1906/2006".

Even this definition is in a H2020 regulation, it can be used in the frame of Horizon Europe.

Only entities performing the project are considered.

Beneficiaries who are not performing the project but which need to be included for administrative reasons are not considered in this frame (that is to say beneficiaries which are declaring no cost in the budget of the project or only charging management costs – cf. budget aspects in part II).

However, please note that beneficiaries linked to affiliated entities and third parties who do not perform the project must sign an accession form to the funding agreement (asked by the EC).

2. Can an affiliated entity or a third party participate in a consortium without its own Beneficiary?

Yes.

However, even if an affiliated entity or a third party can participate in a consortium without its own beneficiary, the beneficiary's costs must be indicated in the budget proposal. More information is available on question 12.

3. Is it possible to add new affiliated entity? Yes, cf. page 17 of the call conditions.



4. What are the requirements for becoming an affiliated entity?

Beneficiary must provide PIANOFORTE with documents proving the legal link between itself and its Affiliated Entity.

The documents will be forwarded to the EC which will either accept or reject the application.

Various documents are accepted: cooperation agreement, MoU, Statement of Intent, Statutes... We do not have any list. Please contact your National Contact Point if you need assistance (see question 22).

The legal link must not only exist for the PIANOFORTE project.

Hence, in case of agreement it must enters into effect before the start of PIANOFORTE (1st June 2022). Retroactive entry into force is accepted so your agreement can be signed after the 1st of June 2022.

The object of the agreement must be wider than PIANOFORTE.

The new Affiliated Entity will be included in the PIANOFORTE Grant Agreement after a procedure that will be communicated to the new Affiliated Entity in due time.

5. How to include in the proposal a participant who is not yet an affiliated entity?

If the participant can be considered, in your opinion, as an affiliated entity and you intend to provide the relevant documents to PIANOFORTE, this entity must be presented in your proposal as a new affiliated entity.

6. Is it possible to add a new beneficiary?

7. Is it possible for international entities (outside of EU) to participate? Yes. They will be considered as associated partners.

8. Who can be coordinator?

Any participant including beneficiaries, affiliated entities or third parties or associated partner but it would be easier from an administrative point of view if it was a beneficiary or an affiliated entity.

9. Is it possible for one legal entity, to participate twice (or more) in the call - i.e. to take part in two or more) different project consortiums, on the same or different research topics?

10. Is it possible for the same researcher to participate in two different projects? $\ensuremath{\mathsf{Yes}}$

11. Can the same institution coordinate more than one project?

Yes, however it is not possible for the same principal investigator to coordinate two projects at the same time.

II. Budget aspects

12. What costs need to be declared in my budget during the proposal phase?

The costs of all the participants performing the project (that is to say entities which are implementing the project from a technical point of view) must be declared.

The costs of the beneficiaries linked to an affiliated entity, or a third party shall also be declared.

In this context, the beneficiary can declare zero (0) cost or only management costs.

Management costs means cost induced from the transfer of funds from beneficiary to affiliated entity, third parties...

Beneficiaries who are declaring no cost or only management costs will not be taken into in the number of participants. They must use the "management" option as visible in the screenshot of the system hereunder.

You must use the Auxiliary Financial Excel Sheet accessible on **PIANOFORTE Website**.

13. What is the funding rate?

PIANOFORTE will reimburse 63% of the eligible costs of each participant which may be funded by PIANOFORTE.

Regarding recipient of financial support to third parties the maximum amount to be granted in the frame of financial support to third parties (for each recipient) is:

- EUR 300 000 for actions justifying the establishment of a Ph.D. or post doc contract or
- EUR 100 000 in other cases of activities for the implementation of the roadmap for research in radiation protection.

Those ceilings cannot be accumulated in the same project. The maximum amount of reimbursement is either EUR 300 000 or either EUR 100 000. The ceiling mentioned hereinabove is global ceiling for all the calls organized in the frame of PIANOFORTE.

14. Financial flows

IRSN will transfer the funds to each Beneficiary.

The sum transferred by IRSN to a Beneficiary will include:



- the sums due to the Beneficiary, its Affiliated Entities, its subcontractors, contributors in-kind, and recipient of financial support to third party as well as
- the sums due by an Affiliated Entity to its subcontractors, contributors in-kind, and recipient of financial support to third party.

Each Beneficiary is in charge of transferring the funds to the Participant which must be paid by said Beneficiary.

Each Affiliated Entity is in charge of transferring the fund to the Participant which must be paid by said Affiliated Entity.

15. Who can be financed or not?

Only entities established in Euratom Member States and third countries associated to Euratom (for now the only third country associated to Euratom is Ukraine) are eligible for receiving the financial support to third parties. Persons, groups and entities subject to EU sanctions cannot participate and cannot be funded.

Associated partners can participate but cannot be funded by PIANOFORTE.

16. Is it necessary to justify how the 37% not financed by PIANOFORTE will be financed?

No. PIANOFORTE is only asking for recipient to financial support to third party a letter stating that it agrees to the financial conditions of the call and the funding of the costs not supported by PIANOFORTE is secured from other sources.

The source does not need to be justified.

17. When do the letter regarding the acceptation of the financial rules of PIANOFORTE by recipient of financial support to third party must be submitted?

This letter must be submitted in the portal with the proposal.

18. What is the minimum and maximum budget of a project consortium?

The total budget of each consortium must be from 1.0 M ${\rm \ensuremath{\mathbb E}}$ up to 1.5 M ${\rm \ensuremath{\mathbb E}}.$

If the budget is lower or higher the project will be refused

The total budget must include the costs of all the participants including the participants which will not receive any funding (e.g. associated partners).



III. Miscellaneous

19. Does the PIANOFORTE have any active system to search for partners in order to create a consortium?"

20. Is a beneficiary liable for the action of its affiliated entities or third parties? Yes, it is in accordance with the grant agreement.
